ROAD MAINTENANCE:

- Bids will be accepted for the June, 7, 2021 meeting for:

 - 2.5 mile of chip sealing

- 2021 road maintenance includes: Michiels Road, JJ to HE, Matt's Lane, Allen Road, South 29 to Pine Grove, 2 miles, south BK Line, 1/4 mile
- Mike Goral and Kevin Taicher will do the patching on road where necessary.
- Pine Grove Road and Trestle Road need shouldering. Kevin Taicher will contact Theys for a bid if more than \$25K, it will go out for bids.

BROWN COUNTY MUNICIPAL COURT: Court is held at the Glemore Town Hall, however, the Town of Glemore is asking the court to move their files into a secure location. Glemore will build a 6x6 building to hold records. The Court is asking participating 10 Towns to budget monies for construction of the shed. Motion was made by Mike Goral and Seconded by Kevin Taicher to budget \$700 for the shed. Motion carried. This will be a one time fee.
