Chairman Jim Osterloh called the Town Board Meeting to order at 7:30pm

**MINUTES:** Motion to accept town board minutes from June 29, 2022. Motion was made by Mike Goral, second by Kevin Taicher. Motion carried.

**TREASURER'S REPORT:** Money market \$386,461.21 checking \$3,239.78 Balance on hand \$389,700.99 Motion to accept treasurer's report by Kevin Taicher and seconded by Mike Goral. Motion Carried.

**NOISE COMPLIANCE ISSUE:** Mandy Mincheski presented a signed petition by surrounding neighbors of Connor Hess, 5628 Blahnik Road, with an issue of recklessly use of fire arms, concerns of safety of the neighbors. Motion made by Kevin Taicher and seconded by Mike Goral to open the floor for public discussion. Discussion was for respect of the neighbors and to be notified when gunfire would occur. Town Board will send a certified letter to Mr. Hess, asking to set parameters of gunfire or to take his practice to a shooting range. Draft of letter would be sent to Mandy Mincheski for review.
